#### ARTICLE I

The name of this corporation is BAILEY'S, INC.

#### ARTICLE II

The term of existence of the corporation is perpetual.

#### ARTICLE III

The purpose of this corporation is to own and operate a coin laundry and any and all other lawful business.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.
