This corporation is authorized to issue One Hundred Shares of One Dollar (\$1.00) par value common stock.

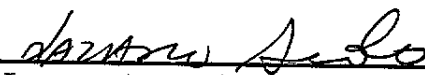

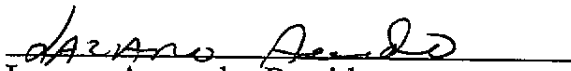
