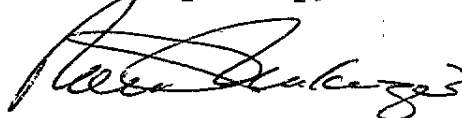

ARTICLES OF INCORPORATION
OF
ROBERT H. MACKENZIE, P.A.

ARTICLE I

The name of this Corporation shall be ROBERT H. MACKENZIE, P.A.

ARTICLE II

The Corporation shall have perpetual existence unless dissolved according to law,

ARTICLE III

This Corporation is organized for the purpose of providing legal services. 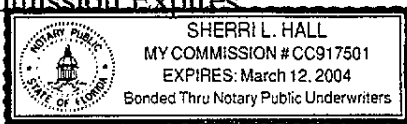

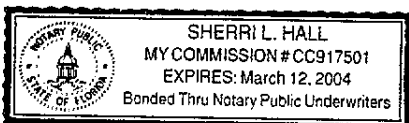
