The undersigned for the purpose of forming a corporation for profit under the provisions of chapter 607, Florida Statutes, and hereby accepts all rights, privileges, benefits and obligations conferred and imposed by said law on corporations to the provisions thereof, and do hereby make, subscribe, certify, acknowledge and file these articles of Incorporation.

**ARTICLE I – CORPORATE NAME**

The name of this corporation is:

**ARTICLE II – DURATION**

The term of existence of the corporation is perpetual, and shall be deemed to have commenced its existence on April 15, 2001

**ARTICLE III – PURPOSE**

This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV – CAPITAL STOCK**

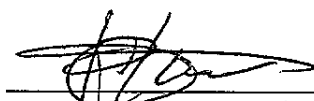

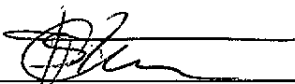

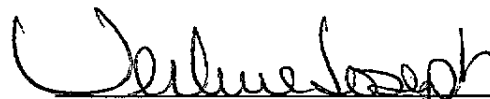
