The undersigned, a natural person competent to contract, does hereby make, subscribe and files these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

ARTICLE I

This Corporation shall indemnify any officer or Director or any former officer or Director, to the full extent permitted by law.

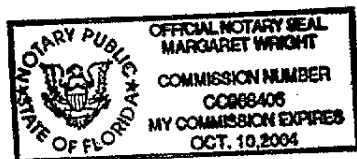




