

I was instructed by my client to formally protest the administrative dissolution of their company know as Golf Worldwide, Inc. This company is affiliated with Sun Promotions US, Inc. Sun Promotions US, Inc. has been filed and is in good standing at the Secretary of State Office since its inception. My office has handled their bookkeeping and records since their inception and I am in fact a signer on their bank account.

Golf Worldwide, Inc. files tax returns in the state of Florida as does Sun Promotions US, Inc. Sun Promotions US, Inc. in which the Director of Golf Worldwide is employed; files payroll tax returns in the state of Florida, sales tax returns, and owes property on which they pay property taxes. They are good and honorable tax payers and timely file their obligations.

You will note from the bank statement of Sun Promotions that two checks were issued to your office for the annual reports of Golf Worldwide, Inc. and Sun Promotions US, Inc. Check number 2846 for \$150 for Sun Promotions and check number 2847 for \$150 for Golf Worldwide, Inc. Both checks were cashed and both were for the Annual Report period of 2003.


I have also enclosed a copy of the Golf Worldwide 2003 Uniform Business Report which was timely filed yet was apparently rejected by your office; although we never received notice of that. When we timely submitted the annual report to be filed for 2004 we received back the check and the notation that the company was administratively dissolved

and we do not believe it should have been. Please accept the 2 checks for the years 2004 and 2005 which are enclosed herewith in the amount of \$150 each and please acknowledge that you received and cashed the check for 2003 (a copy of which is attached).

If this is not acceptable and cannot be approved at your level, please forward this letter to the appropriate level for consideration and notify us of the progress. If necessary, we are willing to meet with the Secretary of state Mr. Christ or speak with him about this matter directly should you instruct us that is necessary.
