

# ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### **ARTICLE 1**

#### NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is GAPASOM, Corp...
