ARTICLES OF INCORPORATION

OF

"TAKE IT TO THE HOUSE BAIL BONDS", INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I- NAME

The name of this corporation is "TAKE IT TO THE HOUSE BAIL BONDS", INC.

ARTICLE II-PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III-DURATION OF CORPORATION

The period of duration for this corporation is perpetual.

ARTICLE IV- CAPITAL STOCK

The aggregate number of shares which this corporation is authorized to issue is

one hundred (100). Such shares shall be of a single class, and shall have a par value of one hundred dollars (\$100.00) per share.

ARTICLE V-PRE-EMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, series or class as that which he or she already holds, shall have the right to purchase his or her pro rata share (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI-INITIAL PRINCIPAL OFFICE AND AGENT



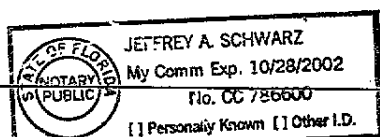


