**ARTICLES OF INCORPORATION
OF

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The initial business of the corporation shall be freelance commercial/business marketing and writing services.

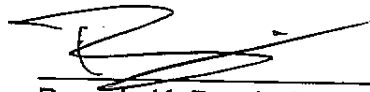
ARTICLE IX
