The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby forms a professional corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.



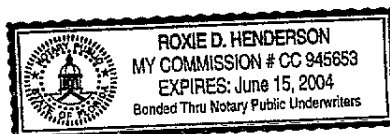
