ARTICLES OF INCORPORATION

OF

ARTICLE I

Name and Mailing Address. The name of the Corporation is J & M SIGNS, INC. (the "Corporation"). The street address of the principal office and the mailing address of the Corporation is 1003 South Orlando Avenue, Winter Park, Florida 32789.

Business and Activities. The Corporation may, and is authorized to, engage in the business of manufacturing and selling custom signs or any other activity or business permitted under the laws of the United States and of the State of Florida.

Capital Stock. The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

Term of Existence. The Corporation shall have perpetual existence.
