


*Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation.*

1. Article V (Initial Board of Directors) of the Articles of Incorporation of **Florida Suncoast Services, Inc.** is amended to read "This corporation shall have one director, James M. Shindledecker. The number of directors may be increased or decreased from time to time by the by-laws, but shall never be less than one(1).

2. Article VII (Registered Agent) of the Articles of Incorporation of **Florida Suncoast Services, Inc.** is amended to read "The name of the registered agent of this corporation is James m. Shindledecker, 5603 Indiana Avenue, New Port Richey, FL 34652.


