I, the undersigned incorporator, hereby make, acknowledge, and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of this corporation shall be TEAM Publishing Corporation.

**ARTICLE II**

**NATURE OF BUSINESS**

The purpose for which this corporation is organized is to engage in any activity or business permitted under the laws of the United States and the State of Florida. Its principal place of business is located at 800 S. Orlando Avenue, Suite 110, Maitland, Florida, 32751.

**ARTICLE III**

**AUTHORIZED SHARES**

The corporation shall be authorized to create and issue 1000 shares of common stock having a par value of \$1.00 per share.

The whole or any part of the authorized shares of the corporation may be issued for a

consideration payable in cash or other property, tangible or intangible or in labor or services actually performed for the corporation, having a value as is determined from time to time by the Board of Directors of the corporation, not less than the par value of the stock so to be issued.

#### **ARTICLE IV**

##### **TERM OF EXISTENCE**

The corporation shall exist perpetually unless dissolved according to law.

#### **ARTICLE V**

##### **INITIAL REGISTERED OFFICE AND AGENT**

The street address for the initial registered office of this corporation in the State of Florida shall be 800 S. Orlando Avenue, Suite 110, Maitland, Florida, 32751.

The name of the initial registered agent of this corporation at that address shall be Judith B. Friedland.

#### **ARTICLE VI**

##### **BOARD OF DIRECTORS**

The corporation shall be managed by a Board of Directors, which shall have three initially. The number of directors may be increased or decreased by the stockholders from time to time as provided by the bylaws of the corporation.

### **SPECIAL PROVISION**

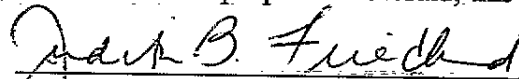
The following additional provisions for the regulation of the business and for the conduct of the affairs of the corporation and creating, dividing, limiting, and regulating the power of the corporation, its stockholders and directors, are hereby adopted as a part of these Articles of Incorporation.

1. No person shall be required to own, hold, or control stock in the corporation as a condition precedent to holding an office in this corporation.

2. The Board of Directors may prescribe a method or methods for replacement of lost certificates, and prescribe reasonable conditions by way of security upon the issue of new certificates therefor.

3. The Board of Directors, by the affirmative vote of a majority of the directors then in office, and irrespective of any personal interest of any of its members, shall have the authority to establish reasonable compensation of all directors, officers and otherwise.

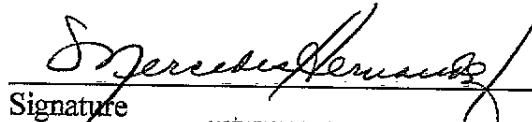

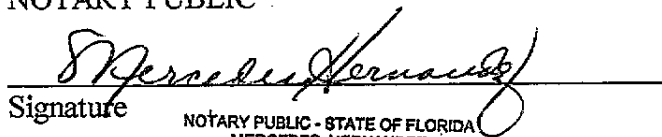
