**ARTICLE 1: NAME**

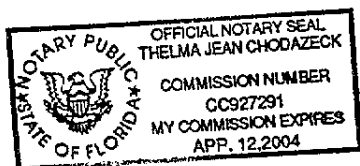

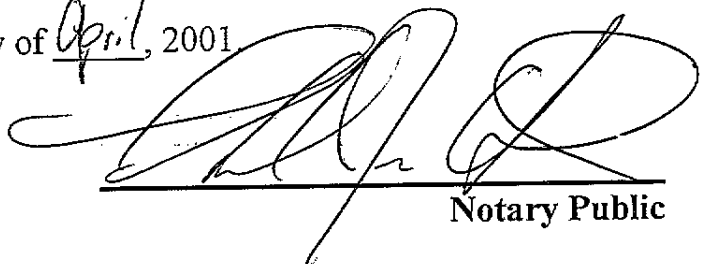
