ARTICLES OF INCORPORATION OF PRETZEL'S OF CORAL RIDGE, INC.

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE ONE

The name of the corporation shall be PRETZEL'S OF CORAL RIDGE, INC. The duration of existence of this corporation shall be perpetual, or until such time as said corporation is by due process of law, dissolved.

ARTICLE TWO

The general nature and objects of the business or businesses to be transacted by this corporation shall be any lawful activity or business permitted under the laws of the State of Florida or the United States of America:

- (a) To buy, sell, lease or rent a building in which to carry on its lawful activities under the Articles of Incorporation.
- (b) To purchase, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal with real or personal property or any legal or equitable interest in property wherever located.

- (d) To lend money to, and use its credit to assist its officers and employees in accordance with Florida Statute 607.0833.
- (c) To purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge or otherwise dispose of; and deal in and with shares or other interests in, or obligations of, any other entity;

- To provide insurance for its benefit on the life of any of its directors, officers or employees or on the life of any chareholder for the purpose of acquiring at his death shares of its stock owned by the shareholder or by the spouse or children of the shareholder; and
- To be a promoter, incorporator, partner, member, associate or manager of any (m) corporation, partnership, joint venture, trust or other entity.
