The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

- 1. The name of the corporation shall be MONARD TOURS, INC.. The principal place of business shall be 1720 County Road 427, North, Longwood, Florida 32750.
 - 2. The duration of this corporation is perpetual unless dissolved according to law.
 - 3. The purposes for which this corporation is organized are:
 - a. To market tour and vacation packages to members of the general public.
- b. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
- c. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.
