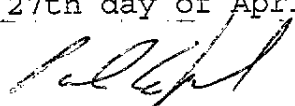
ARTICLE VIII

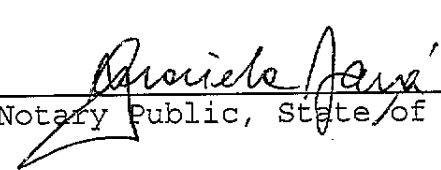

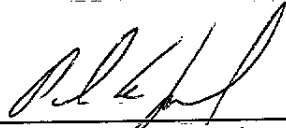
