**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of the corporation is PIWOT CORP.

ARTICLE II - PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE III - AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is five hundred (10,000) shares of common stock having a par value of \$1.00 per share. These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.
