ARTICLES OF INCORPORATION

of

R.L.M. DESIGN CONSULTANTS CORP.

We, the undersigned, hereby associates ourselves for the purpose of becoming a corporation under the Laws of the State of Florida, and under the statute of the State of Florida providing for the formation, rights, privileges, immunities and abilities of incorporating for profit, it is:

ARTICLE I

The name of the corporation shall be:

R.L.M. DESIGN CONSULTANTS CORP.

ARTICLE II

The corporation shall engage in any activity or business permitted under the Laws of the State of Florida and of the United States of America.

ARTICLE III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any time is 500 shares of common stock, and which common stock shall be of par value. (Shall have a par value of \$1.00 per share).

All stock is to be issued as fully paid and exempt for assessment.

ARTICLE IV

The pledge, sale, transfer or other disposition of the capital stock, may be governed and restricted by the By-Laws or written agreement amongst the stockholders which shall be on file in the office of the offices of the corporation so named in Article VII herein.

The By-Laws may provide for cumulative voting by stockholders at all elections of the directors of the corporation.

ARTICLE V

The amount of capital with which this corporation may begin business shall not be less than Five Hundred (\$500.00) dollars.

ARTICLE VI

The existence of the corporation is perpetual.

ARTICLE VII

The Board of Directors may be from time to time move the principal offices to any other address within the State of Florida. The registered agent is: RAFAEL L. MORALEJO, address: 11780 SW 18rd Street Apt 429, Miami FL 33175.

ARTICLE VIII

The business of the corporation shall be managed by a Board of Directors. A quorum for the holding of a meeting of the Board of Directors, and for transaction of any business properly carried out by the directors on behalf of the corporation, shall consist of a majority of the members thereof. 
