ARTICLES OF INCORPORATION

OF

MALONE IGA, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation (the "Corporation") is MALONE IGA, INC.

ARTICLE II

The street address of the principal office of the Corporation is 5413 10th Street, Malone, Florida 32445.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is One Hundred (100), par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IV

The initial street address of the Corporation's registered office is 507 Mathushek Street, Bonifay, Florida 32425. The initial registered agent for the Corporation at that address is Charles H. Dockery.

ARTICLE V



The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


