# ARTICLES OF INCORPORATION OF ROY JOHNSON MASONARY, INC.

# ARTICLE I-Name

The name of this corporation is Roy Johnson Masonary, Inc.

# ARTICLE II- Principal Office

The address of the principal office is 3606 Pugeot Drive, Sebring, Florida 33872 and its mailing address is Post Office Box 1765, Sebring, Florida 33871-1765.

# ARTICLE III-Duration

This corporation shall have perpetual existence.

# ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE V-Capital Stock
