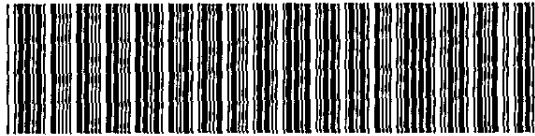




SECOND: The date the adoption of these articles of Dissolution is June 6,2005
