**ARTICLE I - Name**

The name of this corporation is A-1 PAYLESS SEPTIC SERVICE, INC.

**ARTICLE II - Duration**

The period of its duration is perpetual.

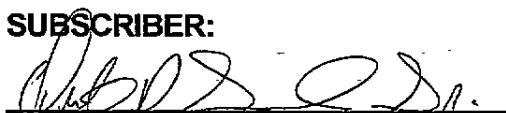
