The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit, under Chapter 607, Florida Statutes, and do hereby certify that it has become such corporation under and pursuant to the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is "XTREME CLEAN PROFESSIONAL FLOOR CARE, INC.". The principal office address of this corporation is 211 Allen Memorial Way, Port St. Joe, Florida 32456.

ARTICLE II

Duration

The corporation shall have perpetual existence, commencing on April 27, 2001.

ARTICLE III

General Purpose Clause

The general nature of the business or businesses to be transacted by the corporation is that it will engage in the cleaning and maintenance of floors. This corporation shall also have the power to transact any lawful business for which corporations may be incorporated to do under Chapter 607, Florida

Statutes and amendments or supplements thereto, and any other Florida Statutes relating to corporations for profit.
