ARTICLES OF INCORPORATION
OF
MEDICAL CONSULTING & BILLING SERVICES, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is MEDICAL CONSULTING & BILLING SERVICES, INC.

ARTICLE II

The existence of the Corporation shall begin on May 1, 2001.

ARTICLE III

The street address of the principal office of the Corporation is 2500 East Hallandale Beach Boulevard, Suite 706, Hallandale Beach, FL 33009.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 125, per value \$.01 per share, all of which shall be Common Shares.
