ARTICLES OF INCORPORATION

OF

GOLFGUIDE, INC.



ARTICLE 1 - NAME

The name of the Corporation is GOLFGUIDE, INC., (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.
