# ARTICLES OF INCORPORATION OF P.D. MUNSON, INC.

ARTICLE I - NAME

The name of this corporation is P.D. MUNSON, INC.

# **ARTICLE II - DURATION**

This corporation shall have a perpetual existence commencing on the date of filing.

#### ARTICLE III - PRINCIPAL OFFICE

# ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand Shares of One Dollar (\$1.00) par value common stock, which shall be designated "common shares".
