Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is HEMODYNAMIX, INC.

ARTICLE II. AMENDMENT TO ARTICLES


Article I of the Articles of Incorporation shall be amended to change the name of the Corporation to Orlando Ultrasound Associates, Inc. by deleting the first sentence thereof and replacing it with the following sentence:

"The name of the corporation shall be Orlando Ultrasound Associates, Inc."
