On or about October 2001 I spoke with a representative to make an address change for my business, the representative mailed out the UBR for 2002 to my new location. I enclosed a payment of \$550.00 with the 2002 UBR, and that form contained the new address, as well. I was under the impression that my corporation had remained active and up to date, as the check of \$550.00 had been cashed October 28, 2002.

I am now having the same problem; I have not received the current UBR form for 2003. I am aware that there is a deadline by May to avoid a fine of \$400.00. On April 4, 2003 I made a call to your customer service department to inquire why I have not received the current information, and spoke with Eula. She advised me that I had to renew my corporation as it had been dissolved since November 2002, and that I should have received information on the mail regarding this; in addition she gave me the option to download the form from the internet to expedite the process.

I should have received information at my new location so that I could be aware of the situation. At this point, I do not understand why the check was cashed if my corporation had already been dissolved. This is extremely unprofessional! In any case, my business is still running and therefore I need to have my paperwork up to date. However, I should not have to pay \$600.00 to renew my corporation. Once more, I made all the changes giving enough time, and paid the fine in 2002, as I was late. Please investigate the account and advise if I can have the reinstatement fee waived. Enclosed you will find the reinstatement form and a payment of \$150.00 for the renewal in 2003.
