ARTICLE XI - PRINCIPAL OFFICE

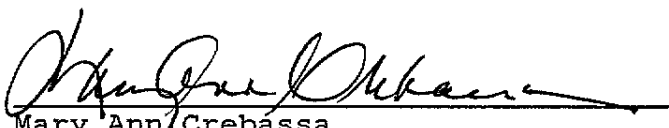
