ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Regis One Investments,

ARTICLE II -- PRINCIPAL OFFICE

The mailing address of this corporation shall be 1785 N.W. 38th Avenue Lauderhill, Florida 33311

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
