ARTICLES OF INCORPORATION OF CORNERSTONE CARPET, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Cornerstone Carpet, Inc. (hereinafter called the "Corporation").
