



This letter is to request consideration for the reduced re-instatement for the above corporation. At the same time we are changing our registered agent, and I've enclosed the form for that as well.

Our former Registered Agent had apparently received the original form for the annual report, but had not notified us of his receipt until just recently. I have no idea how long he had been in receipt of our forms.

In addition, both our office address and his office address changed in early 2002. Our business address was formerly located in an "Executive Suite" of offices. Interestingly enough, so was his. Following the 9/11 tragedy, the U.S. Post Office changed procedures and we were not allowed to put in a change of address for our move. The Post Office no longer records change of addresses for a single business from a suite like that. Current regulations now indicate that a change of address like that would change everyone's address in the suite, therefore we were unable to have our mail forwarded.
