ARTICLE I

Name and Location

1.1. The name of the corporation is SHIBATA, INC. The mailing address of the corporation is 205 Cedar Key Court, Oldsmar, Florida 34677.

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.


