

This letter is notification that we did not receive the 1st UBR request, as it was sent to the incorrect address. We have been at our current address: 5825 La Puerta Blvd. #167, St. Petersburg, FL 33715, since July 2001, and had a change of address in place from July 2001 through January 2002. The change was also mailed to all government entities, and we received both Federal and State returns and filings at this address.

We did not, however, receive the 1st 2003 UBR, because the post office only forwards mail for six months. The 2nd 2003 UBR was forwarded to the correct address, because of the deadline for filing. There is no way we would have intentionally not submitted the 2003 UBR.

As such, we would sincerely appreciate your recommending the fee for not submitting the 1st UBS be rescinded. Sun 1-Company is a very small S Corporation and the fee request will cause bankruptcy.
