#### ARTICLES OF INCORPORATION

### ARTICLE I - Name

The name of this corporation is TENACITY GROUP OF SOUTHWEST FLORIDA, INC.

#### **ARTICLE II - Purpose**

This corporation is organized for the purpose of transacting any or all lawful business.

## ARTICLE III - Capital Stock

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock.

## ARTICLE IV - Preemptive Rights
