ARTICLES OF INCORPORATION

OF

I, the undersigned, being of legal age and natural person do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I
NAME

The name of this corporation is PAZ INVESTMENTS, INC.

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
