**ARTICLES OF INCORPORATION
OF

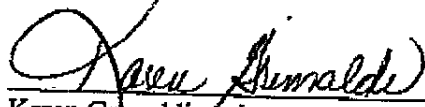
ARTICLE VI. INCORPORATOR

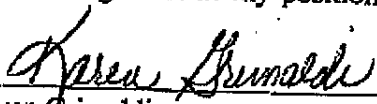
