ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1-NAME

The name of the corporation shall be: Tekpro, Inc..

ARTICLE II-NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III-TERM OF EXISTENCE

The corporation is to exist perpetually.

ARTICLE IV-AUTHORIZED SHARES

The corporation shall have the authority to issue 10,000 shares of common capital stock with a par value of \$5.01 per share.

ARTICLE V-PREEMPTIVE RIGHTS

ARTICLE XII-INDEMNIFICATION

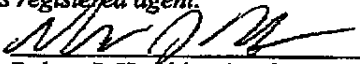
The company shall indemnify its directors, officers, employees, and agents to the full extent permitted by law.
