# ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I. NAME

The name of this corporation is:

**WHITFIELD & ASSOCIATES, INC.**

## ARTICLE II. NATURE OF BUSINESS

This corporation may engage in the insurance and reality business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

To offer, sell and/or advise clientele on all types of insurance products and services related to but not specifically the insurance industry. To advise and consult within respect to the products and services of the insurance business but not limited just sales, service and consulting.

Also to engage in reality business of any kind. To buy, sell, exchange, trade, and Generally deal in real property, improved and unimproved of every class and description; to sell, buy, mortgage, lease or otherwise acquire or dispose of any real property and take mortgages and assignment of mortgages upon the same; to make and obtain loans

upon real estate, improved or unimproved, giving or taking evidence of indebtedness and securing the payment thereof by mortgage, trust, deed, pledge, or otherwise; to enter into contracts to buy or otherwise acquire for the purpose of holding or dispensing of the same, involving real property of any kind and description; to rent or lease office buildings, rental apartments, condominium units and houses, or any other improved real property of any kind or nature whatsoever, and in connection therewith to enter into contracts with rental or leasing agents.

The activities may include, however not limited to, the improvement and repairing, buying and selling, trading of residential homes, business offices as well as other dwellings such government offices, condominiums, apartments, rentals, commercial properties and other activities related to the real estate business..

The company may contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers of corporate property to secure the payment of corporate assets of any other corporation and engage in the same or other character of business. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of capital stock of, or any bonds, securities or any other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock. ### **ARTICLE IV. INITIAL CAPITAL**

The amount of capital with which this corporation will begin business shall not be less than Five Hundred Dollars (\$500.00).

### **ARTICLE V. TERM OF EXISTENCE**

The corporation is to exist perpetually.

### **ARTICLE VI. ADDRESS**

The initial street address of the principal office of the corporation in the State of Florida shall be: 109 Barclay Ct., DeBary, Florida 32713. The Board of Directors may from time to time move the principal office to any other place or places as may be designated by the Board of Directors.
