ARTICLES OF INCORPORATION

of

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I CORPORATE NAME

The name of this corporation is: South Florida Home Management Inc., a Florida Corporation.

ARTICLE II NATURE OF BUSINESS

The nature of the business will be to manage private residential property, and this is not limited to, doing all and everything necessary and proper for the successful operation of this corporation and for the protection and benefit of this corporation.
