**ARTICLE I - NAME**

The name of this Corporation is QUALITY RETIREMENT MANAGEMENT, INC., and its address is 5300 West 16<sup>th</sup> Avenue, Hialeah, Florida 33012.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

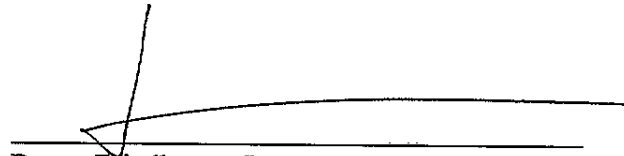

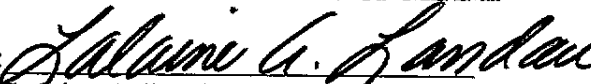
