**ARTICLES OF INCORPORATION
OF**

JANCAR ROOFING, INC.

I, the undersigned, being of full age, do hereby, for the purpose of forming and organizing a corporation for profit under the provisions of the Corporation Laws of the State of Florida, adopt and declare the following Articles of Incorporation covering the existence and organization of the corporation.

ARTICLE I - NAME

The name of this corporation shall be: JANCAR ROOFING, INC.

ARTICLE II - DURATION

The existence of this corporation shall begin upon the filing with the Secretary of State's office, and thereafter the existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation, or the objects or purposes of the corporation shall be as follows:

a. To engage in the general business of building, repairing and maintaining commercial and residential roofs, and any other lawful business under the corporate laws of the State of Florida.

b. To own real and personal property, both tangible and intangible, necessary for the rendering of the above services.

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) per value common stock.
