#### ARTICLES OF INCORPORATION OF

#### WASHINGTON CONSULTANT MULTI - SERVICES, INC.

#### A FLORIDA CORPORATION

ON THE STATE OF STATE The undersigned, acting as an incorporator of Washington Consultant Multi - Services Inc., in compliance with Chapter 607 and/or 621 adopts the following Articles of Incorporation:

#### ARTICLE I. CORPORATE NAME.

The name of this corporation is Washington Consultant Multi - Services, Inc..

#### ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation is 407 South Dixie Hwy, Suite 200, Lake Worth, FL 33460, in Palm Beach County. The corporation is organized pursuant to the Florida profit corporation code.

#### ARTICLE III. PURPOSES.

To provide consultation services to immigrants and United States citizens on issues such as citizenship, passports, visas and translations or any other activity or business permitted under the laws of the United States and Florida.

#### ARTICLE IV. AUTHORIZED SHARES.

This Corporation is authorized to issue 100 (one hundred) shares, all of one class, with a par value of \$1.00 per share.

#### ARTICLE V. INITIAL REGISTERED AGENT AND OFFICE.

The name and address of the initial registered agent is: LEMON ANCENE, 407 South Dixie Hwy, Lake Worth, Florida, 33460.

#### ARTICLE VI. BOARD OF DIRECTORS

The name and street address of the person appointed to act as the initial director of this corporation is Lemon Ancene, 407 South Dixie Hwy, Lake Worth, Florida, 33460. The number of diectors may be changed by an amendment of the bylaws of the corporation, but shall never be less than one.

#### ARTICLE VIII. INCORPORATOR

As executed on the 11th of April, 2001, the incorporator of this corporation shall be: Lemon Ancene, 407 South Dixie Hwy, Lake Worth, Florida, 33460.

#### ARTICLE VIII. DURATION OF EXISTENCE.

This corporation is to exist perpetually.

#### ARTICLE IX. AMENDMENT OF THESE ARTICLES

The Board of Directors of this corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

#### ARTICLE X. DIRECTORS' LIMITATION OF LIABILITY

To the fullest extent permitted by the State of Florida's Business Corporation Act as it exists or may hereafter be amended, no person who is serving or has served as a director of this corporation shall be personally liable to the corporation or to any of its shareholders for monetary damages for breach of duty as a director. No amendment or repeal of this Article nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.

#### ARTICLE XI. VOTING RIGHTS

- A. Cumulative Voting: All shareholders of this corporation have the right to cumulate their votes for directors, and give one candidate as many votes as the number of directors to be elected multiplied by the number of shares, or to distribute them on the same principle among as many candidates as he sees fit, provided, however, that notice shall be given by any shareholder to the President or a Vice President of the corporation not less than 24 hours before the fixed time for the election of directors at which he intends to cumulate his votes.
- B. Pre-emptive Rights: Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right may be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights.

#### ARTICLE XI. INDEMNIFICATION

This corporation may indemnify any officer or director, or any former officer or director pursuant to Florida statutory law.
