ARTICLE I - NAME

The name of this Corporation is AIRPORT CAR CARE, INC.

ARTICLE II - DURATION

This Corporation shall have a perpetual existence commencing on May 10, 2001.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business under the Laws of the United States and of the State of Florida, but specifically for the purposes of repairing and servicing automobiles and selling, servicing and repairing computer systems.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 100 shares of One (\$1.00) Dollar par value common stock, which shall be designated "Common Shares."

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE X - INCORPORATION

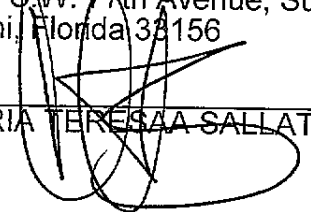

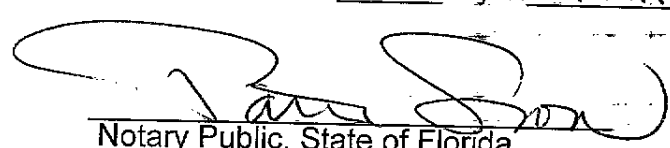
