ARTICLES OF INCORPORATION  
OF

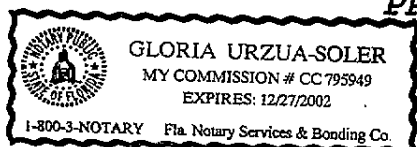
