ARTICLES OF INCORPORATION OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State of Florida

ARTICLE I Name

The name of the corporation shall be:

SPRING VALLEY ENTERPRISES, INC.

2. ARTICLE II PRINCIPAL OFFICE

3. ARTICLE III PURPOSE

4. ARTICLE IV TERM

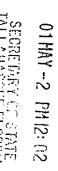
This corporation shall have perpetual existence.
