ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I: NAME

The name of this corporation is Global Cash Advance, Inc.

ARTICLE II: DURATION

The duration of the Corporation is perpetual.

ARTICLE III: NATURE OF BUSINESS

1. To engage in the business of operating all authorized activities.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV: CAPITAL STOCK

The aggregate number of shares that the corporation is authorized to issue are ten-thousand (10,000) shares. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.

ARTICLE V: PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

ARTICLE VI: ADDRESS AND REGISTERED AGENT

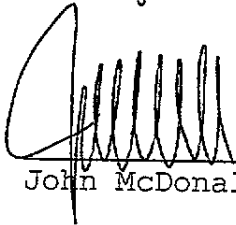

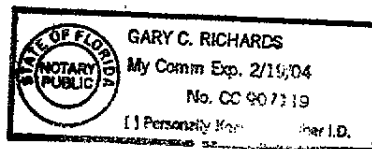


