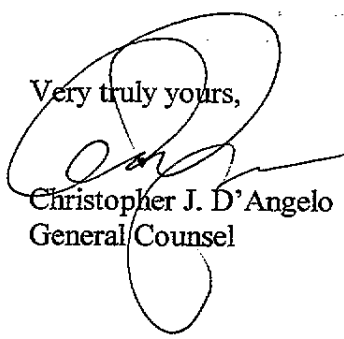

This corporation is to exist perpetually.

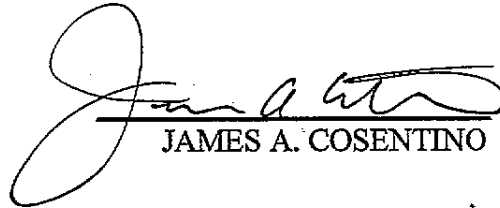
**ARTICLE VI - INCORPORATOR**
