The name of the corporation is ACME PRODUCTION SERVICES, INC.

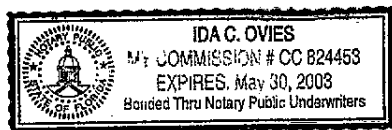
